Car Parking	Volunteers, riders, siblings, staff, horses, parents and carers	Riders remain the responsibility of the parent/carer until on the horse. They must remain aware of their surroundings at all times.	No	All using the car park	Daily
Stables (including Feed Room and Hay Barn)	All users	Access by trained volunteers and staff only. Signage in place.	Make all yard users aware.	Yard staff and volunteers	Daily
Horses	All on the yard	Only trained volunteers and staff to handle the horses.	Train volunteers.	Yard staff and suitably trained volunteers	Daily

Surfaces (Condition & Levelness)	All users	Regular levelling and maintenance.	No	Yard staff and trustees	Daily
Fields / Tracks	All users	Ensure that only staff and trained volunteers have access.	Monitor who has access.	Yard staff and suitably trained volunteers	Daily
Mounting Facilities	All users	A coach must be present and only trained volunteers to assist.	Update training as necessary.	All coaches	Daily

Tack Room / Toilets / Kitchen Area	All users	Notice of hot water above handbasin and sink. Monitor use of kettle and washing machine. All participants to be accompanied / supervised by parent / carer / teacher or two volunteers. Keep it tidy.	Remind all that kettle and washing machine are in use.	Yard staff, coaches and trustees.	Daily
Equipment Storage Area	All users	No access to participants. Keep it tidy.	No	Coaches	Daily
Waiting / Viewing Area / Gallery	All users	Small school – gate to be kept closed until ready to mount.	No	Coaches and volunteers	Daily
Machinery & Tools	All users	All electric items to be PAT tested. All tools locked away in designated shed – kept locked and no unauthorised access sign on door. Only trained staff and volunteers to operate machinery following manufacturers'	Monitor	Yard staff and trustees	Daily
